(a) Presentation by NuGen Capital regarding possible solar power purchase.

David Milner, CEO and Laura Frasier, Director of Operations provided an overview of their current project installing solar panels and equipment on the Stanley Bostitch roof with the intention of selling power credits to the Town in addition to other entities. Brochures were distributed to the Council and a lengthy discussion ensued regarding the process of purchasing credits, whether the School Department should be included in this process, and the appropriateness of the Council to accept a proposal before proceeding with a RFP. Solicitor Teitz disclosed that his firm is doing business w/ NuGen in Bristol and Barrington.

Discussion continued. Councilor Donegan stated that receiving a proposal from them does not create a fair process for the Town or NuGen, or, preclude the Town from proceeding with a RFP. Mr. Duarte recommended hiring a consultant, possibly piggybacking Barrington. Solicitor Teitz suggested postponing receiving their proposal while attempting to have access to the Barrington info, possibly hiring the same consultant.

Councilor Corenthal expressed her appreciation to Mr. Duarte for the informative tour of the Waste Water Treatment Plant, Fire Department and Police Department provided to her and Councilor Englehart.

Councilor Englehart stated her concern over abandoned properties and older homes in disrepair, and would like to see guidelines developed to identify and monitor these properties. President Schwager instructed Joe Duarte to address this issue.

President Schwager remarked that this was the last meeting of the fiscal year, emphasizing that significant milestones have been reached in 2019: adopting 2020 budget with less than 1% tax increase, fully funding schools, returning money to the reserve fund, and completing all five labor contracts. He expressed his appreciation to the Town employees, Department Heads, School Department, fellow councilors, and East Greenwich residents for helping to make these things happen. He thanked Michael D'Amico for his tireless efforts and hard work in reorganizing the Town's finances and helping to reach labor agreements with the unions; and,

wished him the best in his future endeavors. Solicitor Teitz reiterated his comments concerning Mr. D'Amico.
