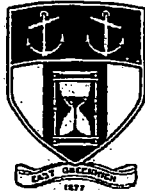

On June 25 2017 at 1800 hours, Anthony Perretta called the police station to report damage to his vehicle. The damage occurred today on Cora Street at 1730 hours. Perretta stated he was driving on Cora Street when he ran over a rubber hose that was across the street. There were two rubber hoses on the street. When Perretta ran one of them over a nail punctured his right rear tire. Perretta could hear a loud noise coming from outside his vehicle. Part of the hose was still connected to the nail as it was punctured into the tire. Perretta stated he purchased the tires not long ago and each cost him approximately \$100.00. I removed the rubber hoses from the street. After looking at the hoses it was clear Perretta's tire was damaged from nails holding down the hoses. The hoses appear to be in the road to count the traffic that passes through Cora Street. The name of the company associated with the hoses is International Traffic Corporation (ITC).
