On March 14, 2017, at approximately 1555 hours I, Patrol Officer David DelBonis badge # 170 was dispatched to 70 Kenyon Avenue to meet with the calling party Matthew Goodwin in regards to the damage that occurred to his vehicle, a 2008 BMW 4 door sedan, which was parked in his driveway with its front end facing Kenyon Ave. Upon my arrival I met with Matthew Goodwin who stated that at approximately 1550 hours he was in his home doing interior work when he heard a snowplow, plowing the street northerly on Kenyon Ave and as it passed by the front of the house he heard a loud bang. Goodwin then went to check on the front of the home and noticed that the snowplow was gone but observed damage to the front left fender of his BMW and damage to his gate. At first Goodwin thought that the plow may have struck his vehicle but after further observation I informed him that there were no tire marks leading up to his car. It appears that heavy wet snow from plow caused the damage as it was pushed up and off the roadway. I took a series of photos were taken of the damage area and the scene. The vehicle received damage to the left front fender.

I then observed a vehicle parked in the driveway on Kenyon Ave at the intersection of Hyland Road with similar type damage. I was able to make contact with the car's owner Andrew Twomey at 69 Hyland who stated that he had just finished shoveling his driveway about 30 minutes prior and there was no damage to his 2013 Saab. The damage was on the vehicle's left front fender.

I took a series of photos of that vehicle also.

East Greenwich DPW was notified and James Fogell responded to the scene.
