## POLICE LOGS

The following reports come from East Greenwich Police logs. All persons named are presumed innocent until proven guilty in court.

### EAST GREENWICH

#### No contact violation

#### Suspended license

## COURT LOGS

Upon switching to a plea of no contest, he was assessed a \$500 fine with one year of probation, 4-month loss of license, 20 hours of community service, DUI school and court costs.

Heather M. Henley, 48, of 20 Branch St., South Kingstown, pleaded not guilty to one count of operating with a suspended license. She was released on \$1,000 personal recognizance and is due back in court Feb. 15 for pretrial.

Jesse Pagliarini, 18, of 263 Kenyon Hill Trail, Richmond, pleaded not guilty to one count of domestic simple assault, one count of domestic refusal to relinquish a telephone and one count of domestic disorderly conduct. He was released on \$3,000 personal recognizance and is due back in court Feb. 8 for pretrial.

Meloni A. Northup, 54, of 90 King's Factory Road, Charlestown, pleaded not guilty to one count of reckless driving. Upon switching to a plea of no contest, the charge was filed for one year with a 45-day loss of license and court costs.

Michael D. Deloughery, 21, of 102 Trask Ave., apt. 1, Bayonne, N.J., pleaded not guilty to one count of reckless driving. He was released on \$1,000 personal recognizance and is due back in court Feb. 15 for pretrial.

Chapin C. Witham, 19, of 161 Biscuit City Road, apt. A, Charlestown, pleaded no contest to one count of operating with a suspended license. He was assessed a \$350 fine with court costs and no further loss of license.

Bryson J. Oakley, 18, of 37 Wyndham Way, apt. 9, South Kingstown, pleaded not guilty to one count of domestic disorderly conduct and one count of vandalism. He was released on \$2,000 personal recognizance, issued a no contact order and is due back in court Feb. 8 for pretrial.

"or other forms of speech that ridicule, malign, disparage, or otherwise bias against any race, any religion, or any protected class of individuals." The policy goes on to instruct town employees to always "be fair and courteous to fellow co-workers and the public and avoid inappropriate postings [...] that violate the Town's policies, such as anti-discrimination and anti-harassment
