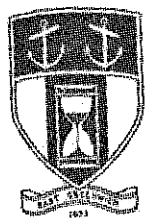

Jeff and Elizabeth Keithline for property located at 205 Kenyon Avenue; Assessor's Map 84, Plat 9, Lot 284 (Zoned R-30, Residential). The Applicant seeks a Special Use Permit to allow an accessory family dwelling unit (for In-law use only) on the property. A dimensional variance is also required because the shed structure proposed for conversion to a dwelling unit is non-conforming in terms of the side setback and the overall height. Chapter 260 of the Town Code, Zoning Ordinance, Section 9(C) establishes the provision for these accessories to be permitted by special use permit. Relief is also required from Chapter 260-9(E) and Table 2 - Table of Dimensional Regulations by Zone which together establish a maximum height of 15 feet for accessory structures and a side yard setback of 30 feet.

Chapter 260 of the Town Code, Zoning Ordinance, Section 20 stipulates the required number of off-street parking spaces required for this combination of uses. 45 spaces will be provided where 46 are required. Additionally, Section 24 of the same chapter requires a loading zone for the proposed use and the applicant seeks to have this requirement waived.
