The vote is disclosed pursuant to Section 42-46-4 (b) of the Rhode Island General Laws was made by Andrew Deutsch, seconded by Sean Todd

Solicitor D'Agostino read the motion aloud which said "A motion to authorize the Declaratory Judgement action discussed and to also begin the effect bargaining made by VP Todd, seconded by Councilor Deutsch. President Cienki, VP Todd, Councilor Deutsch and Councilor Granatiero voted aye and Councilor Schwager voted nay. The motion carried 4-1.

- (7) <u>Public Hearing</u>
 - (a) Transfer application for a Class BV Alcoholic Beverage License with Victualing and Entertainment from Beso's Kitchen and Cocktails d/b/a Besos Kitchen and Cocktails to TMG Main Street Holdings d/b/a Beso's Kitchen and Cocktails 378 Main Street

Attorney Christopher Mulhearn represented TMG Main Street Holdings, LLC, the proposed transferee, and was accompanied by Thomas J. Martucci, the sole principle. He provided details

on Mr. Martucci's restaurant experience and explained that all administrative actions have been addressed related to the request for transfer. Council had no questions. There were no public comments.

- (9) <u>New Business (Discussion/Action)</u>
 - (a) Presentation of Audit FY 2017

President Cienki reported that the audit is available on State website; however, the Auditor was not available to present it so it will be rescheduled and presented during a joint meeting with the School Committee. She deferred to the Town Manager to provide highlights.

Town Manager Corrigan provided a brief overview, focusing on three aspects: statement of net position (page 7), combined surplus or deficit (pages 9, 11 and 117) and unassigned fund balance (pages 16, 46, 116).

Discussion ensued on bond ratings, reporting of the Fire District impact fee settlement, school surpluses, deficits and Town allocations.

(b) Ratification of May 2017 MOA between Town of East Greenwich and NEARI concerning exempt classification change, original MOA executed by Mr. Clarkin on May 4, 2017.

Motion to ratify made by Sean Todd, seconded by Nino Granatiero

Solicitor D'Agostino explained there is no record of the MOA being brought before the Council giving the former solicitor the authority to execute the document for approval.

(c) Ratification of MOA between Town of East Greenwich and NEARI concerning proposed April 2018 reclassification change, contract extension, and stipend payment.

Item was tabled.

(d) Sewer Assessment waiver/abatement for Howland Road parcel, following merger and September 2016 litigation settlement terms.

Motion to approve made by Sean Todd, seconded by Andrew Deutsch

Solicitor D'Agostino provided some history on the abatement related to a sewer assessment on an un-buildable lot that was merged with another lot.

(e) Consideration of the Fire Department reorganization plan discussed at the April
9, 2018 Council meeting, including Council vote to authorize action thereon.

Motion to accept the recommendations of the Town Manager to reorganize the Fire Department from its current 4-platoon/42-hour workweek structure to a 3-platoon/56-hour workweek structure, which this Council received through the Town Manager's report and discussed at our meeting on April 9, 2018; provided, however, we will hold in abeyance the implementation of the reorganization pending a decision on the current motion for judgment on the pleadings scheduled to be heard by the Rhode Island Superior Court on May 14, 2018, or until further action by this Council made by Sean Todd, seconded by Nino Granatiero

Solicitor D'Agostino provided an overview and an update on the status of the litigation the Town has filed in Superior Court. A response is expected on May 14th. The intent of this action is to hold the re-organization plan in abeyance until the court makes its decision. Following the motion, there was further discussion about the purpose of the motion and Council's ability to reorganize and/or implement any of the changes recommended by the Town Manager. Town Manager Corrigan indicated that a preliminary financial impact analysis has been done; however, its completion is hanging on Judge McGuirl's decision. Additionally, a staffing model based on IOD's and the Council's final vote to implement would affect the financial impact. Councilor Schwager commented on why he is unable to support the motion based on the strategy, tactics and risk associated with it. President Cienki commented on the fiscal responsibilities the Town is facing.

(10) Public Comments (30 minute time limit)

Eric Jautaikis, 184 Hemlock Drive, commented on the proposed fire department platoon restructuring. He disseminated a chart (Exhibit A) that compared hours of work for a 4 platoon schedule versus a 3 platoon schedule. He was concerned with the potential risks of sleep deprivation and the impression that fiscal relief was more important than safety.

Robert Vespia, 155 Shippeetown Road, disputed last year's tax break.

Eric Kaldor, 525 Stone Ridge Drive, requested that any financial impact statements related to the fire department reorganization are made available to the public in advance of meetings. He was concerned about new ways overtime could be created with a restructuring.

David Caldwell, 8 Aurora Road, expressed his frustration with Council on many levels. He disputed the Town Manager's proposal to reorganize the Fire Department and encouraged residents to participate in the upcoming election in November.

Caryn Corenthal, 5 Brookfield Court, disputed some of the comments made by Town Manager Corrigan related to the audit. She remained concerned about Council's intent to reduce costs within the Fire Department without concern for rising legal fees. She questioned accounting practices for billable legal services still pending.

Elizabeth McNamara, 18 Prospect Street, received a brief update on the Town Manager search which remains confidential.

William Perry, 5 Pardon Woods Lane, voiced his concern about the Council versus the Town Manager's intent to reorganize the Fire Department. Discussion ensued with President Cienki. Mr. Perry questioned Council's due diligence prior to voting for a 56 hour workweek and filing litigation. He commented on impending legal bills. President Cienki replied that Council was always willing to sit down to negotiate. Mr. Perry spoke about a fire call on Main Street and firefighter safety.

(11) Council Comments

VP Todd commented that the vote taken for the 3 platoon, 56 hour workweek was the most common structure in America.

President Cienki commented on concerns related to firefighters out of work due to injuries and budgeting for FY 2019.
